The Morrison Government is today launching a \$21.9 million Indigenous Leadership and Governance package to support the next generation of Indigenous leaders.

The Indigenous Leadership and Governance package includes:

- \$13.5 million for the Australian Indigenous Mentoring Experience (AIME) to continue its operations and implement a strategic plan for expansion to support young Indigenous Australians to undertake leadership roles, further education and employment;
- \$6.7 million for Office of the Registrar of Indigenous Corporations (ORIC) to develop governance training materials for Indigenous organisations; and
- \$1.7 million to the National Indigenous Australians Agency (NIAA) to provide scholarships for Indigenous Australians to undertake company directors' courses, and to monitor and evaluate the entire package.

Prime Minister Scott Morrison said the \$21.9 million investment would support thousands of Indigenous individuals and many organisations to realise their potential.

"Our \$13.5 million investment in the Australian Indigenous Mentoring Experience program will extend this successful program by three years to 2025 and expand its support to 10,000 students a year, up from the current 6,000 students a year," the Prime Minister said.

"This will ensure even more young Indigenous Australians can realise their leadership potential and career dreams through this proven mentoring and skills development program, and become the next generation of leaders in business, community and the public sector.

"In addition, Indigenous businesses will be strengthened with a \$6.7 million investment in governance, and we are providing \$1.7 million to deliver scholarships for Indigenous Australians to undertake company director courses to provide Aboriginal and Torres Strait Islander people with the skills to take their business to the next level or sit on the boards of our top companies.

"This is about maximising the burgeoning opportunities for Indigenous entrepreneurs and businesses, as well as the economic advancement of all Indigenous Australians. With the right supports and opportunities, even more Indigenous Australians will be able to launch from entry-level roles into higher-skilled and higher-paying technical, managerial and leadership careers."

Minister for Indigenous Australians the Hon Ken Wyatt AM, MP said the package would help to realise the recently released National Roadmap on Indigenous Skills, Jobs and Wealth Creation.

"When I launched the Roadmap at the end of last year it was clear that we need to strengthen Indigenous leadership and governance capability across the nation," Minister Wyatt said.

"This is about supporting the aspirations of Indigenous youth to dream big and thrive at no matter what they turn their minds to as well as providing the tools for all Indigenous businesses and business people to take the next step towards expansion or leadership roles.

"Since 2005, AIME, an Indigenous organisation, has supported more than 25,000 young Aboriginal and Torres Strait Islander people to further their education and kick-start their careers, with an average of 96.1 per cent of their participants attaining Year 12 and moving on to further education or employment."

The recent Indigenous Australian Workforce Report delivered by Skills Australia confirmed that, on average, Indigenous people tend to work in high growth but lower skill level jobs.

"This funding will help turn that around, providing the launching pad Indigenous Australians need to develop leadership skills and network to support them on their journey," Minister Wyatt said.

This package directly supports Priority Reforms Two and Three of Closing the Gap and contributes to the overarching aims of the Government's Roadmap for Indigenous Skills, Jobs, and Wealth Creation.

IMAGI-NATION {University}

6. University Student Ambassadors — each participating university campus will have five University Student Ambassadors. Ambassadors will undertake online courses and training. Ambassadors will recruit and train other university students to become mentors and build partnerships with high schools. Between June and December Ambassadors will be tasked with establishing regular Tutor Squads in partnered schools. The goal will be to provide academic support for First Nations students, with at least 10 sessions provided to each school. In addition, Ambassadors will also work to plan and host IMAGI-NATION {Factory} Days, which bring mentees from partner schools to the university campus. Targets are set out below:

High School Student Ambassadors — students will take on an Ambassadorship and will be given the training, tools and support to develop their own project for change that will alleviate educational inequity. With coaching and support from AIME staff, a learning journey plan will be developed, co-designed and implemented from May to December. Students will also be connected to a wide network of mentors and gain access to work experience and job opportunities. They will be mentored and coached throughout the year as they develop their skills in leadership, organisation and entrepreneurship. MentorClass

9. MentorClass is a new digital resource designed to equip students with the creativity, adaptability and resilience required to forge a successful post-school career in the job market of the future. The project will see video mentoring lessons paired with teaching resources and activities for students and their teachers. Offered as a free platform, MentorClass will give teachers across Australia access to a suite of classes that will grow over time. The content will also include elements of co-design with teachers and students feeding their ideas back

IMAGI-NATION {TV}: Dreamspace

10. IMAGI-NATION {TV} uses Zoom to create a live YouTube show that brings together mentors from around the world and marginalised students. Dreamspace represents the next season of IMAGI-NATION {TV} and First Nations students will be given the opportunity to pitch a project that will benefit their school community. Each episode will feature one school, including a small group of students and one teacher, to work through a co-design session with AIME to identify a problem to be solved and create a solution. The students will share their projects during an IMAGI-NATION {TV} special, to a guest panel of experts, corporate executives and entrepreneurs, with the goal of finding ways to bring their dream to life. Targets are set out below:

Operating as AIME's new headquarters, the IMAGI-NATION {Factory} will serve as a place that can host the AIME program and welcome schools and mentors from across Australia and the world the opportunity to engage with the AIME program and the broader community. JOY (Just your Organisation and You)

13. Staff of corporate partners become mentors to Indigenous high school students. The model sees organisations, including major corporate partners, set up their own Tutor Squads with local high schools. Working through child protection requirements and AIME's Mentor Training, employees of engaged organisations will be able to provide regular academic support to Indigenous students in schools located near their place of work. As with the university program a Tutor Squad runs across 1–2 school terms and sees mentors work alongside students for one hour per session. AIME will provide ongoing support, networks and coaching to organisations engaged in JOY.

- 15. The Provider must deliver workshops and mentoring by trained AIME staff and volunteer mentors. The Provider must endure that all staff and volunteers delivering workshops and mentoring have been trained to adequately fulfil the duties required of them.
- 16. The Provider must provide new staff employed to deliver the Project a rigorous induction and training process, and ongoing training for existing staff.
- 17. Each volunteer mentor must complete two rigorous, AIME-specific mentor training sessions for volunteer mentors to prepare them for working with students. The total training provided will be a minimum of three hours per mentor.

General terms and conditions

- 18. To be eligible, students must identify as Aboriginal or Torres Strait Islander people.
- 19. The Provider must use funds only to meet the costs of delivering the project, including IT; employment of Provider staff; to meet reasonable costs of engaging speakers, Indigenous facilitators and university student mentors; and to meet reasonable expenses incurred developing project resources and delivering the workshops, including workshop materials, food and transport.
- 20. The Provider must submit to the Commonwealth, all reports specified in Clause 7 of this Project Schedule.

IMAGI-NATION {TV}: Dreamspace

10. IMAGI-NATION {TV} uses Zoom to create a live YouTube show that brings together mentors from around the world and marginalised students. Dreamspace represents the next season of IMAGI-NATION {TV} and First Nations students will be given the opportunity to pitch a project that will benefit their school community. Each episode will feature one school, including a small group of students and one teacher, to work through a co-design session with AIME to identify a problem to be solved and create a solution. 




