As we discussed in our recent meeting, the Government is committed to the co-design of options for an Indigenous voice at the local, regional and national level. To support this important work, I am establishing a Senior Advisory Group to guide the co-design process and advise me throughout the process.

I am pleased to invite you to be a member of the Senior Advisory Group. Your leadership and expertise will be critical in supporting the development of options for Indigenous voices for the Government's consideration. The Senior Advisory Group will be underpinned by two specific co-design groups, one to focus on local and regional decision-making, and the other on options for a national voice.

The co-design process is intended to finalise options for the Government's consideration by October 2020, and to that end I am establishing the Senior Advisory Group for an initial term of twelve months. The Senior Advisory Group will be co-chaired by Professor Tom Calma AO and Professor Marcia Langton AM.

I am proposing that the first meeting of the Senior Advisory Group will occur on 13 November 2019. If you accept my invitation to join the Senior Advisory Group, the National Indigenous Australians Agency will provide you with further information including proposed terms and conditions, remuneration and a contract for consideration.
